Data for the months of November & December 2020. Ms. Beth Trotta stated that they had 21 calls requesting service. Of that 4 were referred out or not eligible/not appropriate or no response. 15 did not return paperwork. 3 did not show for orientation/intake. For admissions we had 5 and 1 discharge. We have 83 for DMHAS admissions and 69 for Non-DMHAS. The current active

caseload is at 146. We accumulated in-kind services of 12 hours. We had accumulated 320 billable hours. Productivity is at 50% No Show Rate 13.4%, and number of Clients service hours (appointments made and kept) 597. Revenue this period \$38,211.18 – (Fees/Ins: \$38,211.18 includes Cares Act Payment \$4,505.17) /FY 2021 to date \$116,336.07. Total FY 2020 \$231,104.00
